Post-study work visa pilot in new T4 guidance: watch your compliance KPIs

The Home Office published its new Tier 4 policy guidance document at the end of July. It sees the re-introduction of post-study work visas – on a pilot basis only, working with 4 universities - Bath, Cambridge, Imperial College and Oxford.

The Home Office says these institutions have been chosen because of their very low visa refusal rates.

The new work visas are limited to 6 months duration and if the visa holder finds a long term job and wishes to stay longer, they will have to go through Tier 2 entry processes.

Although only a pilot scheme, which the Home Office says will be closely monitored, this policy move may signal a more differentiated and targeted approach to student visas, with extra 'privileges' being granted to certain institutions, but with concomitant extra compliance responsibilities.

The importance of maintaining robust Tier 4 processes is underlined. Compliance KPIs such as (more...)

The Mexico meetings were follow-ups to the 2015 signing of the main Mexico-UK mutual recognition agreement. The focus was on the various annexes to the main agreement and on technical issues relating to particular qualification comparabilities.

In addition to work on Bachelor, Masters, and Doctoral degrees, agreement was reached on recognition of certain Mexican tertiary sub-degree qualifications and, at postgrad level, a sub-Masters level qualification that is commonly offered. This will be very useful for Mexican students seeking study opportunities in the UK, as the credit transfer position will be much clearer for entry into UK Bachelor and Masters programmes respectively.
